The Elk Township Board of Supervisors August Meeting convened at 7:00 PM at the Elk Township Building, Lewisville, PA. The following Supervisors were present: Chairman Albert Jezyk, Jr., and Vice Chairman Estace Walters. Member James George was not present.

PUBLIC COMMENT ON AGENDA ITEMS

There was no public comment.

ADMINISTRATIVE ACTION/PRESENTATIONS/CORRESPONDENCE Christian Fisher Application for Post Construction Stormwater Management Plan dated 627-17 (Amish Schoolhouse 708 Old Forge Road); AECOM Correspondences dated 7/12/17

Al Jezyk stated that at the last meeting, the Board agreed to sign the plan and maintenance agreement, and that all issues have been addressed.

Al Jezyk stated that DEP has approved the C. Mildred Gregg Sewage Facilities Planning Module. The subdivision plan review is still pending and the applicant needs to submit the original deed of dedication for the additional right-of-way.

Al Jezyk stated that the Chester County Conservation District has determined To-Jo Mushrooms NPDES (National Pollutant Discharge Elimination System) application to be inadequate (technically deficient).

On a motion made by Estace Walters, seconded by Al Jezyk, the Board granted the Stormwater Management Ordinance Section 305.A waiver request. The vote was unanimous amongst Supervisors present.

On a motion made by Estace Walters, seconded by Al Jezyk, the Board agreed to sign the "Stormwater Best Management Practices (BMPs) and Conveyances Operations Management Agreement". The vote was unanimous amongst Supervisors present.

On a motion made by Estace Walters, seconded by Al Jezyk, the Board approved the "Stormwater Management Plan and Erosion & Sediment Control Plan" dated March 20, 2017 latest revision July 17, 2017 for the DuVall-Wolfe project (1007 Chrome Road). The vote was unanimous amongst Supervisors present.

Lancaster Home Builders Lots 1 & 3 SWM Plans – AECOM Correspondence dated 8/2/17; Lancaster Home Builders Correspondences dated 7/7/17 SWM Ordinance Waiver Requests; SWM Best Management Practices (BMP's) and Conveyances Operation & Maintenance Agreements

On a motion made by Estace Walters, seconded by Al Jeyzk, the Board granted the Stormwater Management Ordinance Section 106.B.1 and Section 105.C.1waiver requests for Lot 1 and Lot 3 conditioned upon all Stormwater Management Ordinance comments being addressed and upon

On a motion made by Estace Walters, seconded by Al Jezyk, the Board approved the Stormwater Management Plan for Lot #1 Lancaster Home Builders conditioned upon the signing of the O & M Agreement and any remaining plan issues being addressed as per AECOM correspondence dated August 2, 2017. The vote was unanimous amongst Supervisors present.

Al Jezyk stated that Lot 3 may need to apply for a Zoning Hearing.

Anita Callaghan Application for Post Construction Stormwater Management; Building Permit Plan; Erosion & Sedimentation Plan; Agreement for Professional Review Services

Al Jezyk stated that the Zoning Officer reviewed the Anita Callahan building permit application plan and determined that a Stormwater Management Plan is required. The Township has forwarded the Application for Post Construction Stormwater Management, Building Permit Plan and E & S Plan to the Township Engineer for review.

On a motion made by Estace Walters, seconded by Al Jezyk, the Board agreed to sign the Agreement for Professional Plan Review Services. The vote was unanimous amongst Supervisors present.
