Resolution No. 2012-02 Agricultural Security Area Property Owner Wilson King Tax Parcel #70-3-22

On a motion made by Estace Walters, seconded by Al Jeyzk, the Board adopted Resolution No. 2011-02 adding the Wilson King Tax Parcel #70-3-22 to the Elk Township Agricultural Security Area. The vote was unanimous.

<u>Chester County Planning Commission Correspondence dated December 12, 2011 Review of Proposed Zoning Ordinance Amendment</u>

Pal Durborow referred to Chester County Planning Commission correspondence dated December 12, 2011 reviewing the proposed Elk Township Zoning Ordinance Amendment. The Commission's comments included that the current submission contains the same language as was

previously reviewed except for two additional subsection; and that the provisions of the two additional subsections are appropriate.
