SPCA 2014 Limited/Full Contract

Estace Walters referred to Township correspondence to Penn DOT dated December 16, 2013 regarding maintenance and safety concerns. Estace has reviewed the Township's list of concerns with Penn DOT representative Steve Austin and will continue to monitor Penn DOT's progress.

County-wide Act 167 Update #40 Re: Ordinance Corrections

Al Jezyk referred to County-wide Act 167 Update #40 noting that corrections to the Act 167 Ordinance are required.

On a motion made by Estace Walters, seconded by Jim George, the Board authorized Stan Corbett to proceed with amendments to address the County's corrections. The vote was unanimous.

Jim George stated that the Township tried to make the Act 167 Ordinance less onerous to single lots.

<u>COSTARS PA Department of General Services Salt Contract Participation Agreement</u> <u>August 2014 - July 2015 Season</u>

On a motion made by Estace Walters, seconded by Al Jezyk, the Board agreed to the COSTARS PA Department of General Services Salt Contract Participation Agreement August 2014 - July 2015 Season for 250 tons of Sodium Chloride (road salt). The vote was unanimous.

Act 537 Sewage Facilities Planning Assistance - DEP Correspondence dated December 31, 2013

Al Jezyk referred to Pennsylvania Department of Environmental Protection correspondence dated December 31, 2013 stating that the Department has awarded the Township \$14,979.92 to be paid when the Department receives adequate appropriation from the General Assembly.
