PUBLIC COMMENT ON AGENDA ITEMS

<u>ADMINISTRATIVE ACTION/PRESENTATIONS/CORRESPONDENCE</u> 2012-2013 Bid Proposals – Roadwork Equipment Rental, Winter Road Maintenance Equipment Rental, Aggregate Materials, Blacktop Mixes, Liquid Asphalt

The Township received the following 2012/2013 Roadwork Material & Equipment Rental Bid Proposals:

- 1. Harlan Construction Company Road Maintenance Equipment Rental Bid Proposal in the amount of \$27,100.
- 2. Carter & Son Lawncare, Inc., Winter Road Maintenance Equipment Rental Bid Proposal in the amount of \$63,930.00.
- 3. Martin Limestone, Inc., Aggregate Material Bid Proposal in the amount of \$7,165.50

No bid proposals were received for Blacktop Mixes or Liquid Asphalt.

On a motion made by Estace Walters, seconded by Al Jezyk, the 2012/2013 Winter Road Maintenance Equipment Rental Contract was awarded to Carter & Son Lawncare, Inc. The vote was unanimous.

On a motion made by Estace Walters, seconded by Al Jezyk, the 2012/2013 Aggregate Material Contract was awarded to Martin Limestone, Inc. The vote was unanimous.

2012 Oxford Region Comprehensive Plan Public Review Draft

Pal Durborow stated that the 2012 Oxford Region Comprehensive Plan Public Review Draft is available for review. The Joint Public Hearing for discussion and possible adoption of the plan is scheduled for July 25, 2012 at 7:00 PM at the Herr's Visitor Center in Nottingham.

Natural Areas Stewardship Assessment for the Springlawn Road Trail

Pal Durborow stated that the Natural Lands Trust Stewardship Assessment for the Springlawn Road Trail is complete. The Board agreed to follow-up with Natural Lands Trust for a pdf version of the assessment.

Chester County Board of Commissioners Reestablishment of Municipal Fee for Emergency Services & Chester County Association of Township Officials (CCATO) Request for Vote of Support for Reasonable & Acceptable Solution

Pal Durborow stated that the Chester County Board of Commissioners is considering reestablishment of the municipal fee for emergency services. This fee was done away with in the

early 90's and reestablishment could cost Elk Township \$7,000 per year. The Chester County Association of Township Officials is requesting support to work towards an acceptable solution.

On a motion made by Estace Walters, seconded by Al Jezyk, the Board agreed to support the Chester County Association of Township Officials to work towards an acceptable solution. The vote was unanimous.

Pal Durborow referred to Travelers Casualty & Surety Company Site Restoration Cancellation Notice dated June 19, 2012 for the Mt. Olivet Road tower. The notice includes a cancellation date of September 24, 2012 and is in compliance with bond terms. The Zoning Officer will confirm the site has been restored to original condition and equipment removed.
