PUBLIC COMMENT ON AGENDA ITEMS

There was no public comment.

ADMINISTRATIVE ACTION/PRESENTATIONS/CORRESPONDENCE TOJO Mushrooms (TJA Properties) Preliminary Land Development Plan Agreement to Extend Requirements of the PA Municipalities Planning Code Section 508 (53 P.S. 10508)

Pal Durborow referred to the Oxford Area Recreation Authority January 13, 2011 Meeting Minutes stating that West Nottingham has voted to joint the authority, and that the authority is applying for a new county grant of \$75,000.

Pal Durborow referred to Brandywine Conservancy Correspondence dated February 17, 2011 stating that the property of Stephen & Lydia Fisher UPI #70-3-38.3 has been preserved with a conservation easement.

<u>Brandywine Conservancy – Robins Property UPI #70-3-15 Conservation & Trail Easements Project</u>

Pal Durborow referred to Brandywine Conservancy correspondence regarding the status of the Robbins conservation and trial easement project. Pal stated that Elk Township's share for the easement purchase would be \$184,400.

Pal Durborow referred to Chester County Tax Collection Committee correspondence dated February 18, 2011 providing an update on the transition in tax collectors.

<u>PSATS 89th Annual Educational Conference & Trade Show April 17-20, 2011 – Attendance Authorization & Designation of Township Voting Delegate</u>

The Board authorized Township Secretary, Terri Kukoda, to attend as voting delegate the PSATS 89th Annual Educational Conference & Trade Show.

Chrome Barrens 2011-2012 Season Hunting Permits

Pal Durborow stated that Mr. Robbins is having his property surveyed to determine the property line. Pal stated that fifty (50) Chrome Barrens Hunting Permits were issued last year and that this amount needs to be lowered. The Board agreed to issue eighteen (18) 2011/2012 Chrome Barren Hunting Permits, to issue permits by a lottery system, and to require hunters attend a meeting to pick up their permits. The Township will send a letter to last year's hunters regarding these changes.
