8. INCIDENT DETAILS

On the above listed date and time members of the PSP Avondale Barracks were dispatched to Canterbury Court, Elk Township, Chester County for a reported attempted burglary. Several PSP Avondale units were on scene within approximately 4 minutes. Victim #2 on scene related that at approximately 1225 hours, she observed a white in color smaller four door sedan, unknown make or registration, arrive in front of her residence. This vehicle was occupied by two Hispanic males who exited the vehicle and approached her residence on foot. Moments later Victim #2 heard a knock at her front and observed a Hispanic male, early 20's, tattoos on the upper arms, wearing a short sleeved shirt and denim cargo shorts. Victim #2 further explained that the second male described as a Hispanic male, lighter complexion, early 20's, tattoos on the upper arms, wearing similar clothing, was located at the rear door of her residence attempting to gain entry. Victim #2 observed that the Hispanic male located at the rear of her residence was brandishing a semi-automatic pistol. This prompted Victim #2 to contact PSP Avondale at which time the Hispanic males fled the scene in the above listed vehicle. Victim #2 further explained that she observed a blue in color minivan following in trace of the white sedan as it fled the area.

A few minutes' later PSP Avondale Barracks members were dispatched to Glen Hope Road, Elk Township, Chester County for a reported Robbery which was committed following an interrupted burglary at the residence. Victim #1, while driving past his daughter's residence (Victim #3), observed a suspicious vehicle, blue in color Dodge Caravan mini-van, unknown registration, backed into the driveway. Victim #1 stopped and approached this vehicle on foot to investigate. Victim #1 then heard rustling coming from the interior of the garage and believed that the residence was being burglarized. Victim #1 was in the process of contacting PSP Avondale when a Hispanic male, dark hair, wearing a bandana covering his face, grey t-shirt and dark pants, appeared at the side of the garage and ordered him to the ground at gun point. Victim #1 described the weapon as a dark in color semi-automatic pistol. Victim #1 fled the front yard of the property on foot as the Hispanic male entered the blue in color Dodge Caravan mini-van and fled the scene westbound on Glen Hope Road towards Canterbury Court. The actor involved in this incident stole a rifle and ammo which was located in the residence.

Both of these incidents occurred in close proximity and are believed to be connected due to the information received. These incidents appear to be random and the victims do not appear to have been targeted. It appears that the suspects did not know the residences were occupied.
