

**ELK TOWNSHIP APPLICATION/PERMIT TO HUNT
IN THE CHROME BARRENS CONSERVANCY**

The Board of Supervisors of Elk Township is pleased to allow hunting in the Chrome Barrens and wish to continue this practice for many years. Your cooperation in abiding by the regulations stipulated below, and your consideration of residents living outside the hunting area, will assure hunting activities will continue. The Board reserves the right to limit the amount of permits to be issued and reserves the right to issue permits as follows: Residents of Elk Township receive first priority; residents of East Nottingham, New London, and Franklin Townships receive second priority; residents of all other Townships/Boroughs in Chester County will receive third priority. (If you are issued a permit, you will receive a copy of this application signed by a Township Representative. If you are not issued a permit, you will receive notification of such via U.S. Mail.)

Instructions

Hunter must **sign and notarize** this application and return **via U.S. Mail** to Elk Township, P.O. Box 153, Lewisville, PA 19351. A Certificate of Liability Insurance (listing Elk Township as additional insured) or Homeowners Insurance Policy Declaration Page must be included with the Application. Applications must be postmarked no later than August 25, 2015.

Conditions

Permits are valid for the September 2015 through January 2016 hunting season and is evidence of a restricted privilege to lawfully hunt wild game on the Chrome Barrens Conservancy in Elk Township. As a condition the undersigned agrees to the following:

1. To provide a Certificate of Liability Insurance coverage releasing Elk Township of any responsibility for the hunter's actions, or copy of the Homeowner's Insurance Policy Declarations Page.
2. To obtain all other necessary licenses to hunt game in season in the State of Pennsylvania.
3. To release Elk Township from liability from any claim for losses, injury or expenses which the undersigned may incur while using this permit on the Chrome Barrens Conservancy in Elk Township.
4. All hunters must be respectful of surrounding properties. This is permission to hunt on Elk Township property ONLY. You must not roam onto adjoining properties or shoot onto adjoining properties.
5. There is to be no trash or deer carcass's left on the property.
6. Hunting is allowed only during daylight hours and there is no hunting on Sundays.
7. TO OBEY ALL PA STATE GAME COMMISSION LAWS.
