And now, this 7th day of April 2025 upon motion duly made and accepted, the Board of Supervisors of Elk Township, by unanimous decision, duly agree to accept the following General Fee Schedule to be effective immediately:

I. SUBDIVISION/RE-SUBDIVISION

A. PRELIMINARY SUBDIVISION PLAN (Major Only)

- 1. Application Fee \$200.00
- 2. Escrow for Professional Reviews \$2,000.00 plus \$300.00 per lot (Professional reviews will be charged at actual costs and shall be added to as necessary. Any excess shall be refunded to the Applicant.)
- 3. The Township shall collect a ten percent (10%) administrative fee on all distributions from the escrow account.
- 4. All fees and escrow must be paid to the Township at the time of application or plan submittal.
- 5. Every application for Subdivision shall include a Professional Plan Review and Escrow Agreement signed by the landowner(s) and any agent, tenant or any other person submitting an application for Subdivision.

B. FINAL SUBDIVISION PLAN (Minor & Major Subdivision)

- 1. Application Fee \$200.00
- 2. Escrow for Professional Reviews \$2000.00 plus \$150.00 per lot (Professional reviews will be charged @ actual cost and shall be added to as necessary. Any excess shall be refunded to the Applicant.)
- 3. The Township shall collect a ten percent (10%) administrative fee on all distributions from the escrow account.
- 4. All fees and escrow must be paid to the Township at the time of application or plan submittal.
- 5. Every application for Subdivision shall include a Professional Plan Review and Escrow Agreement signed by the landowner(s) and any agent, tenant or any other person submitting an application for Subdivisions.

II. LAND DEVELOPMENT

A. <u>PRELIMINARY LAND DEVELOPMENT PLAN (Major Only)</u>

- 1. Application Fee \$200.00
- 2. Escrow for Professional Reviews \$2,000.00 plus \$90.00/1,000 sq. ft. floor space (Professional reviews will be charged @ actual cost and shall be added to as necessary. Any excess shall be refunded to the Applicant.)
- 3. The Township shall collect a ten percent (10%) administrative fee on all distributions from the escrow account.
- 4. All fees and escrow must be paid to the Township at the time of application or plan submittal.
- 5. Every application for Land Development shall include a Professional Plan Review and Escrow Agreement signed by the landowner(s) and any agent, tenant or any other person submitting an application for Land Development.

B. FINAL LAND DELELOPMENT PLAN (Minor & Major)

- 1. Application Fee \$200.00
- 2. Escrow for Professional Reviews \$2000.00 plus \$30.00/1,000 sq. ft. floor space (Professional reviews will be charged @ actual cost and shall be added to as necessary. Any excess shall be refunded to the Applicant.)
- 3. The Township shall collect a ten percent (10%) administrative fee on all distributions from the escrow account.
- 4. All fees and escrow must be paid to the Township at the time of application or plan submittal.
- 5. Every application for Land Development shall include a Professional Plan Review and Escrow Agreement signed by the landowner(s) and any agent, tenant or any other person submitting an application for Land Development.

III. POST CONSTRUCTION STORMWATER MANAGEMENT

A. STORMWATER MANAGEMENT PLAN (not submitted with a SB/LD Plan)

- 1. Application Fee \$200.00
- 2. Escrow for Professional Reviews \$2000.00 (Professional reviews will be charged @ actual cost and shall be added to as necessary. Any excess shall be refunded to the Applicant.)
- 3. The Township shall collect a ten percent (10%) administrative fee on all distributions from the escrow account.

- All fees and escrow must be paid to the Township at the time of application or 4. plan submittal.
- 5. Every application for Stormwater Management shall include a Professional Plan Review and Escrow Agreement signed by the landowner(s) and any agent, tenant or any other person submitting an application for Stormwater Management.

IV. **ZONING HEARING**

- A. Application Fee - \$1200.00
- B. Escrow for Costs - \$850.00 (Will be charged @ actual cost and shall be added to as necessary. Any excess shall be refunded to the Applicant.)
- C. All fees and escrow must be paid to the Township at the time of application.

V. CONDITIONAL USE HEARING

- A. Application Fee - \$1200.00
- Escrow for Costs \$850.00 B. (Will be charged @ actual cost and shall be added to as necessary. Any excess shall be refunded to the Applicant.)
- C. All fees and escrow must be paid to the Township at the time of application.
